The **Policy Council on the Right to the City and Inclusive Territories** is an essential mechanism to advance UCLG members' conversation on the Right to the City. While continuing to address key priorities such as shifting the narrative around migration and the right to housing, this mechanism is now set to explore a wider emerging agenda: From renewing approaches equality and accessibility to advancing a new generation of rights.

Since its creation in 2017, the Council has functioned as a platform for in depth policy debate where political representatives can influence the agenda of the World Organization and establish synergies as well as discuss how scale-up specific impact of initiatives led by members, such as the work on housing that led to the adoption of the "Cities for Adequate Housing" Declaration in 2018 and the contribution to the Marrakech Mayors Declaration on Migration that marks the path on a new narrative on Human Mobility. The Council represents a periodic and structural meeting point to address **UCLG's commitment towards the Right to the City** as recognized in the Bogotá Commitment and the New Urban Agenda (both adopted in 2016).

# Potential priorities for the next phase include leading a policy and action-oriented work that engages the whole network in:

- Expanding the *policy discussion on human rights* throughout the definition of the People's Axis on the Pact of the Future, exploring concepts such as the new generation of rights that includes the right to peace, accessibility, technology, mobility and culture.
- Generate Discussions to support the renewal of *the Global Charter-Agenda for Human Rights in the City* which will be promoted by the Committee on Social Inclusion, Participatory Democracy and Human Rights (UCLG-CSIPDHR).
- Informing the partnership with the Office of the High Commissioner for Human Rights (OHCHR) and participation within the UN Human Rights system (e.g UN Special Procedures).

- Accelerating the localization of human rights in the city by adopting and promoting universal accessibility as a common good and pillar to equitable public service provision, sustainable development and participatory democracy.
- Assessing the impact of COVID-19 on the local implementation of the right to the city and how a rights-based approach can contribute to the UN concept of **Build Back Better and the equitable Decade of Action**.
- Co-creating a political declaration on Migration and Human Rights to expand upon Lampedusa's proposal of a Charter for Peace in the Mediterranean.
- Explore and reinforce a territorial vision that addresses and protects human mobility as a right at all stages of the migration process and regardless of legal status.
- Addressing the reduction of inequalities through community-driven narratives that value diversity and equity; exploring the following issues: cities as a common good, challenges of peripheral territories, violence against women and girls, migration, universal accessibility, digital rights, cultural rights, and rights to public services.
- Exploring an Agenda on Dignity in response to the rights of all populations to the city.

# **Links with other Policy Councils:**

Discussions on the mandate and work of this Policy Council relate and provide potential for strong linkages with the debates of other councils, including priority areas such as women's leadership, gender equality and the right to peace and solidarity. The links stemming from these priority areas are essential to further developments on the implementation of the New Urban Agenda and the objectives of the Policy Council on Opportunities for All.

### Links with Pact for the Future axes:

Members' contributions in the next phase of this Policy Council are intended to pioneer the inclusion of frontier contents and priorities in UCLG's discussions around the Pact for the Future (to be adopted in 2022) with a special emphasis on its axis on the **Pact for People**.

The Pact for People will address issues related to socioeconomic inclusion in the aftermath of the COVID-19 crisis. This Policy Council's focus - local approaches to human rights, new generation rights, the transformation of social inclusion and equality agendas, the narrative around migration, and the promotion of the right to housing - will be instrumental in providing fresh perspectives, innovative approaches and expertise by leading local governments on this matter, accelerating the transformation of the municipal movements' social agenda in the coming period.
